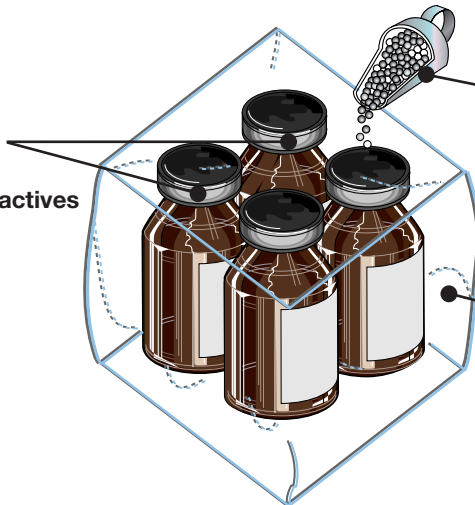
Vermiculite IS Required as absorbent filling of remaining available space.

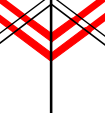


**Vermiculite (CODE 38)**

Completely fill the Polythene Bag, Covering the Product.

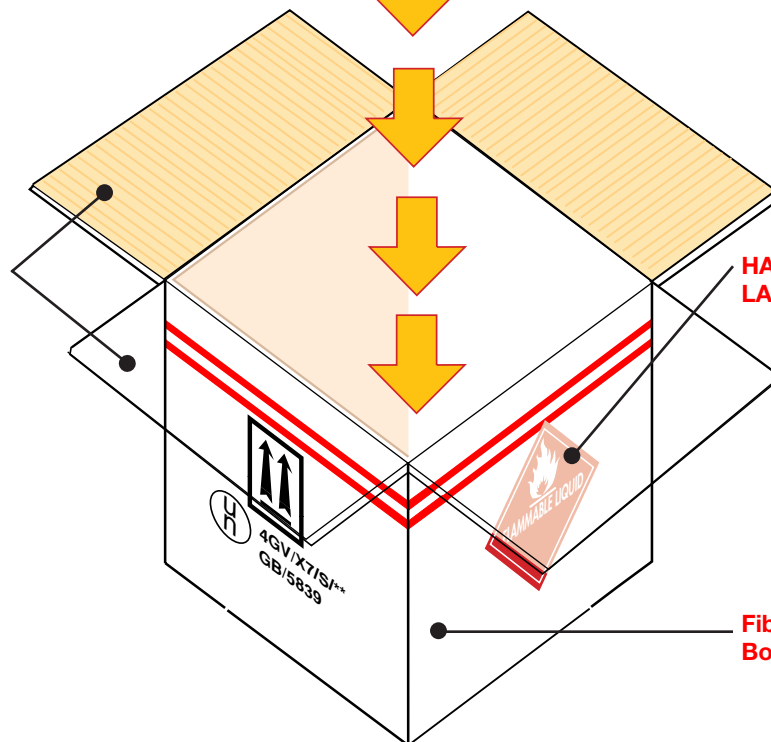
**POLYTHENE BAG**

### FIBREBOARD BOX: 4GV OUTER PACKAGING

## INSTRUCTIONS FOR USE:

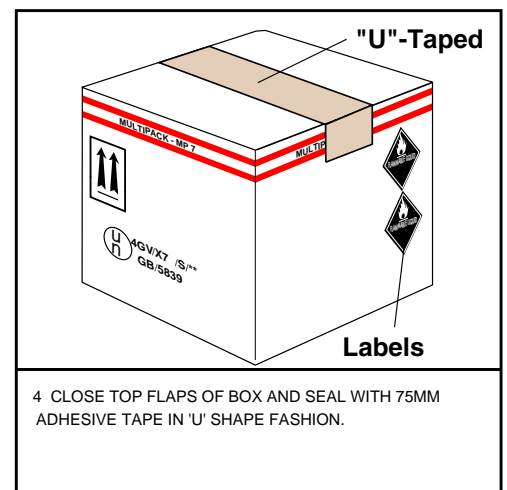
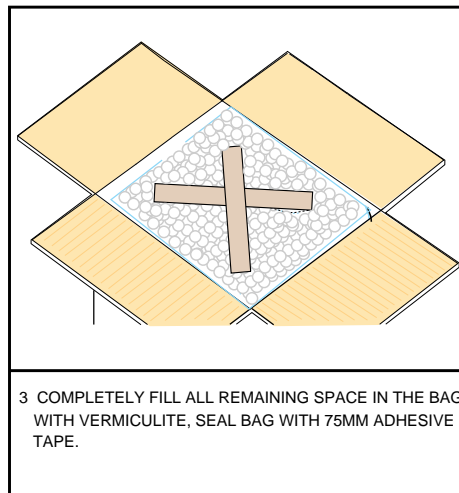
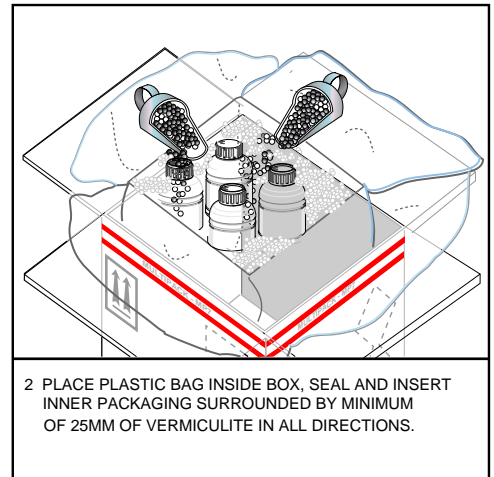
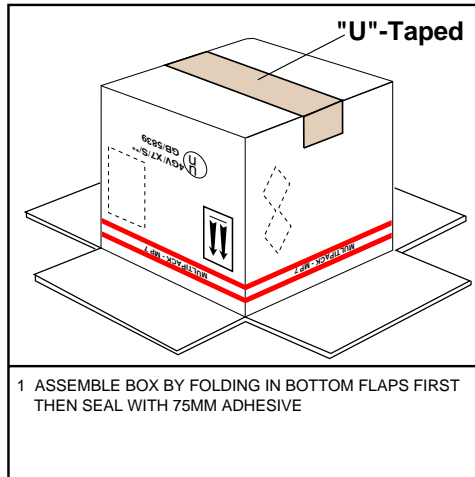
Refer to the illustrations on this page and overleaf.

1 ASSEMBLE BOX BY FOLDING IN BOTTOM FLAPS FIRST THEN SEAL WITH 75MM ADHESIVE TAPE IN 'U' SHAPE FASHION.

2 PLACE PLASTIC BAG INSIDE BOX, SEAL AND INSERT INNER PACKAGING SURROUNDED BY MINIMUM OF 25MM OF VERMICULITE IN ALL DIRECTIONS.

3 COMPLETELY FILL ALL REMAINING SPACE IN THE BAG WITH VERMICULITE, SEAL BAG WITH 75MM ADHESIVE TAPE.

4 CLOSE TOP FLAPS OF BOX AND SEAL WITH 75MM ADHESIVE TAPE IN 'U' SHAPE FASHION.



IT IS THE SHIPPERS RESPONSIBILITY TO ENSURE ALL APPROPRIATE REGULATIONS GOVERNING THE TRANSPORTATION OF DANGEROUS GOODS ARE STRICTLY FOLLOWED.

Our MULTIPACK, is a special 4GV OUTER PACKAGING approved under U.N. Test criteria which allows transport of NON-SPECIFIED INNER CONTAINERS and their contents up to a stated maximum weight."

In MULTIPACK - MP 7 the maximum permitted weight of the INNER CONTAINERS AND THEIR PRODUCT CONTENTS *must not exceed 4.6 KILOGRAMS*, whilst the GROSS PACKAGE WEIGHT *must not exceed 7 KILOGRAMS*.

MULTIPACK - MP 7 *must be assembled and packed strictly as instructed* and is then approved for the transportation of Packing Groups I, II, III, (X, Y, Z) Dangerous Goods.

**CLASS 1 EXPLOSIVES OR CLASS 7 RADIOACTIVES MUST NOT BE PACKED IN THIS BOX.**
